Abstract

OBJECTIVE: To initiate dialogue and inspire reflections on the role of family-based treatment (FBT) in the Nordic countries, discuss shared dilemmas, and elicit joint reflections on "_the how and why_" of future development of FBT-inspired treatment.

DESCRIPTION: Outpatient family-based treatment (FBT) for anorexia nervosa (AN) in young persons (YP) is recommended across national guidelines. Variations of this approach, empowering parents to take on an active role in their child's recovery, are practiced in many places in the Nordic countries. The variations reflect new developments within the field as well as local organizational needs and possibilities in the effort to extend the method to more YP´s with ED. Presenters will share different aspects of FBT-implementation in the Nordic countries.
